While on the captioned subject, it is to state that company has encountered severe business loss due to lockdown announced by the Central/State Government to contain spread of COVID-19 pandemic. We are furnishing herein under the impact of lockdown on the business operations of the company segment-wise as intimation under Regulation 30 of the SEBI (LODR) Regulation, 2015 ('Listing Regulations').

The company is engaged in the business of manufacturing LPG Cylinders & LPG Bottling and is sub-serving the National PSUs Oil Companies. So also it is a Parallel marketeer of LPG & Auto LPG. Although LPG is an essential commodity; company is working with partial workforce during the lockdown period announced by the Central/State Government. It has badly affected the business of the company drastically lowering the company sales during last week of March, 2020, April, 2020 & May, 2020.

Presently the company has recommenced limited activities with restricted manpower and will be opened gradually in a phased manner taking into account the relevant guidelines which will prevail from time to time. As stated supra, although the company is engaged in the business of essential commodities, it ayes to recover the huge losses gradually with the phasewise unlocking of the lockdown period.

It is worthwhile to state here that Company is most concerned with the health & safety of its workforce and is complying with all necessary safety measures at its workplace to contain spread of COVID-19 Pandemic as per the directives issued by the Central/State Governments and local administration.
