

Confidence Petroleum's Q1FY 2020 PAT grows 14.66 % y-o-y to INR 15.32 crore

Commenting on the performance, **Mr. Nitin Khara, Chairman & Managing Director** said:"In spite of drastic fall in LPG Prices in International market company has maintained the profitability. LPG prices came down significantly in the month of April to June 2019 by approx 15%. However company has maintained the profitability due to proper product mix. The growth plans is temporary delayed because of parliamentary elections and code of conduct in the month of April and May. A Large no of Auto LPG stations fully constructed but could not be commissioned because all government officials were busy in election process. we are expecting a major boost in coming quarter.

Segment-wise Business Highlights

Retail LPG - contributed 71.40% toQ1FY2020 consolidated revenue

- Q1 FY20 Revenue at INR 199.85 crore, up 74.03% y-o-y. This includes both Auto LPG and Packed LPG business LPG Bottling, and other Ancillary businesses.
- Confidence Petroleum markets LPG under the brand name GoGas
- The company is one of the largest private sector players in AUTO LPG Dispensary Stations. 10 new stations were added during the quarter, leading to an aggregate of 196 Auto LPG Stations across India. Company enjoys significant market share in the major cities of its operations. Confidence remain on track to achieve 280 Auto LPG stations by the end of March 2020. This is part of its goal of setting up 500 Auto LPG stations by March 2022.
